

# MINUTES OF THE NAPA COUNTY – BOARD OF SUPERVISORS MEETING COUNTY OF NAPA

November 17, 2020

1. CALL TO ORDER; ROLL CALL

The Board of Supervisors of the County of Napa met in regular session on Tuesday, November 17, 2020 at 9:00 a.m. with the following supervisors present: Vice Chair Alfredo Pedroza, Supervisors Ryan Gregory, Belia Ramos and Brad Wagenknecht. Chair Diane Dillon was excused. The meeting was called to order by Vice Chair Alfredo Pedroza.

## **Human Services**

A. Director of Health and Human Services requests the Board recommend to the California Department of Health Care Services that Alternatives for Better Living serve as the sole licensee providing Driving under the Influence (DUI) services within Napa County.

- B. Director of Library Services and Community Outreach requests authorization to accept a grant from the State Library, in the amount of \$5,000 for the Crisis Collection funding opportunity to enhance or expand electronic materials collections.
- C. Director of Planning, Building and Environmental Services requests the following pursuant to recommendations by the Wildlife Conservation Commission: Approval of, and authorization for the Chair to sign the following grant agreements for the term July 1, 2020 through June 30, 2021 for proposals of \$5,001 or greater for a total of \$29,513:
