RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, APPROVING A 4.0% COST OF LIVING ADJUSTMENT FOR THE DEPUTY SHERIFFS' ASSOCIATION LAW ENFORCEMENT AND LAW ENFORCEMENT SUPERVISORY UNITS, EFFECTIVE JUNE 25, 2022

WHEREAS, Government Code section 23500 provides in relevant part that the Board of Supervisors shall provide for the number, compensation, tenure, appointment and conditions of employment of County employees and that such action may be taken by ordinance or resolution; and

WHEREAS, Section 2.100.270 of the Napa County Code provides that the "Table and Index" may be amended from time to time by resolution of the Board of Supervisors; and

WHEREAS, the Memorandum of Understanding between the DSA Law Enforcement and Law Enforcement Supervisory Units provide for a Cost of Living Adjustment (COLA) for employees whose salaries have not been Y-rated, effective the first pay period in Fiscal Year 2022-2023 in the amount of 4.0%.

NOW, THEREFORE, BE IT RESOLVED that the Napa County Board of Supervisors hereby approves a COLA of 4.0% for the DSA Law Enforcement Unit and Law Enforcement Supervisory Unit employees whose salaries have not been Y-rated, and related changes to the Table and Index of Classes, effective June 25, 2022, the first pay period of Fiscal Year 2022-2023.
