RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, AMENDING THE TABLE AND INDEX OF CLASSES, EFFECTIVE JULY 1, 2022.

- **WHEREAS,** Article 11, Section 1(b) of the California Constitution provides that the Board of Supervisors shall prescribe by ordinance the compensation of its members; and
- **WHEREAS,** on June 15, 2005, the Board of Supervisors approved Ordinance No. 1263, which sets the salary of members of the Napa County Board of Supervisors as equal to 47.09% of the salary the Superior Court Judges; and
- **WHEREAS,** on July 20, 2022, the County received notification that the Superior Court Judges received a salary adjustment increase of 1.80% effective July 1, 2022; and
- **WHEREAS,** on October 18, 2022, members of the Napa County Board of Supervisors received a salary increase under the above-referenced Ordinance to keep their salaries equal to 47.09% of the salary Superior Court Judges effective July 1, 2022; and
- **WHEREAS,** on December 8, 2022, the County received notification that the Superior Court Judges received an additional salary adjustment of 0.8940% in addition to the 1.80% previously provided, to a newly calculated 2.71% effective July 1, 2022; and
- **WHEREAS,** pursuant to the above-referenced Ordinance, members of the Napa County Board of Supervisors must receive a salary increase to keep their salaries equal to 47.09% of the salary of Superior Court Judges; and
- **WHEREAS**, the Table and Index reflecting the salary received by members of the Board of Supervisors must be adjusted accordingly, and
- **WHEREAS,** Section 2.100.270 of the Napa County Code provides that changes to the Table and Index shall be established from time to time by resolution of the Board of Supervisors; and
- **WHEREAS,** the Director of Human Resources recommends that the proposed changes to the Table and Index, as set forth in Exhibit "A," for members of the Board of Supervisors effective July 1, 2022.
- **NOW, THEREFORE, BE IT RESOLVED,** that the Napa County Board of Supervisors hereby approves the changes to the Table and Index, as set forth in Exhibit "A," reflecting a salary increase for members of the Board of Supervisors effective July 1, 2022.
