RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, DESIGNATING OFFICERS AUTHORIZED TO DIRECT THE TRANSFER OF TOBACCO SETTLEMENT FUNDS

WHEREAS, the Attorney General of the State of California and representatives of a number of California counties and cities, including Napa County ("County"), entered into a Memorandum of Understanding ("MOU") which allocates a portion of settlement proceeds stemming from litigation against various manufacturers of tobacco products; and

WHEREAS, the County has, in consideration for receiving its portion of the settlement proceeds as allocated to cities and counties in the MOU, executed the Agreement Regarding Interpretation of MOU and the Release, approved by the Judicial Council Coordination Proceedings 4041 Court; and

WHEREAS, the County wishes to continue to receive its allocated share of settlement proceeds as provided for and set forth in the MOU; and

WHEREAS, the Board of Supervisors ("Board") adopted a resolution on March 7, 2000, authorizing specified officers to direct the transfer of the County's settlement funds on behalf of the County; and

WHEREAS, the Board subsequently adopted other resolutions from time to time, amending the list of officers authorized to direct the transfer of the County's settlement funds on behalf of the County; and

WHEREAS, the County again needs to update its designation of officers authorized to direct the transfer of the County's settlement funds on behalf of the County;

NOW, THEREFORE, BE IT RESOLVED by the Napa County Board of Supervisors, that the following officers or their successors in office shall be authorized to direct the transfer of the County's settlement funds on behalf of the County:
