

## **FIRST AMENDMENT TO NAPA COUNTY AGREEMENT NO. 200277B**

**THIS FIRST AMENDMENT TO AGREEMENT NO. 200277B** is made and entered into as of this 14th day of September, 2021 by and between the COUNTY OF NAPA, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and **KAMER CONSULTING GROUP, LLC**, whose business address is 952 School Street, No. 450, Napa, CA 94559, hereinafter referred to as "CONTRACTOR."

### **RECITALS**

**WHEREAS**, the COUNTY, through its Purchasing Agent, entered into Agreement No. 200277B ("the Agreement") on March 10, 2020 with CONTRACTOR for specialized services, as authorized by Government Code section 31000, to provide public relations and communications Support; and

**WHEREAS**, due to the pandemic, performance of some of the services under the Agreement could not be completed; and

**WHEREAS**, the parties would like to extend the term of the Agreement to allow CONTRACTOR to complete performance of those services.

**NOW, THEREFORE**, COUNTY and CONTRACTOR hereby amend the Agreement in the manner set forth below.

### **TERMS**

1) Paragraph 1 of the Agreement, entitled "**Term**" is amended to read in full as follows:

**"Term of the Agreement.** The term of this Agreement shall commence as provided in the original Agreement and shall expire on June 30, 2022 unless terminated earlier in accordance with Paragraphs 9 (Termination for Cause), 10 (Other Termination) or 23(a) (Covenant of No Undisclosed Conflict); except that the obligations of the parties under Paragraphs 7 (Insurance) and 8 (Indemnification) shall continue in full force and effect after said expiration date or early termination in relation to acts or omissions occurring prior to such dates during the term of the Agreement, and the obligations of CONTRACTOR to COUNTY shall also continue after said expiration date or early termination in relation to the obligations prescribed by Paragraphs 15 (Confidentiality), 20 (Taxes) and 21 (Access to Records/Retention)."

2) All other terms and conditions of the Agreement, except as amended herein, shall remain unchanged and in full force and effect.
