8. BOARD OF SUPERVISORS REPORTS AND ANNOUNCEMENTS

Supervisor Belia Ramos reported on attending a legislative advocacy meeting on behalf of the Association of Bay Area Governments (ABAG) and Metropolitan Transportation Commission (MTC) yesterday in Sacramento along with Supervisor Alfredo Pedroza, who is at the continuation of the meeting today. The focus of the meeting was on a housing bond and a future transportation revenue measure. Supervisors from many other counties complimented Napa County on receiving a \$5 million Bay Area Housing Fund Association (BAFHA) grant to address housing insecurity for Seniors, and Supervisor Ramos acknowledged Director of Housing & Homeless Services Jennifer Palmer and her team on their efforts.

Vice Chair Anne Cottrell reported on the Broadband team meeting last week. A recently completed strategic plan will be brought before the Board this spring; they have received a LATA grant and are working with Valley Internet; and Vice Chair Cottrell introduced Information Technology Services Broadband Project Manager Mark Revis. Vice Chair Cottrell also reported on attending a meeting with the UpValley Family Center. They received a grant from the Listos California program, which required them to survey residents who receive their services, and one of their takeaways was that in rural areas after the winter storms of 2022, residents needed a little more information on how to prepare for storms. The feedback provides the County an opportunity to partner with nonprofits, such as Napa Valley Community Organizations Active in Disaster (COAD), and to have the County's Operation of Emergency Services (OES) provide further education for residents in rural areas.

Supervisor Ryan Gregory reported the Fire Resources Fair will be happening this Saturday from 10:00 AM to 2:00 PM at the Napa Valley Expo and is sponsored by the Napa Valley Vintners, Napa Valley Grapegrowers, Napa Communities Firewise Foundation, and Cal Fire.

Chair Joelle Gallagher reported some elected officials throughout the valley and their respective staff members had the opportunity to attend a workshop presented by U.C. Berkeley Haas School of Business Senior Lecturer and Director of New Management of Technology Programs Andrew Isaacs, who teaches climate and business. It was an incredible day of learning, and there will be another workshop for elected officials and their staff, as well as opportunities for the public.
