The schools take a huge chunk of that, and the rest will go into other areas such as the gas tax rebate, and infrastructure. On the Assembly side there is a huge push for Infrastructure projects. Fire Prevention and Suppression will also be a priority. CARE Court is ongoing as discussions between local government stakeholders and the Governor continue.
