EXECUTIVE SUMMARY

California Government Code 1031 requires peace officers to be of “good moral character” and free from any “emotional or mental condition which might adversely affect the exercise of powers”. In order to comply with the code, Napa County Department of Corrections (Corrections) has contracted with Valley Clinical and Consulting Services for psychological evaluations. Corrections has been satisfied with the service provided and

would like to continue utilizing their expertise.

Amendment No. 4 to Agreement No. 160106B with Valley Clinical and Consulting Services will amend the evaluation cost to \$550 per evaluation through June 30, 2022, and to \$600 per evaluation from July 1, 2022, through contract termination date of June 30, 2024.

Today’s requested action is for approval of this amendment and will allow Corrections to continue receiving this pre-employment service on an as-needed basis.
