### EXECUTIVE SUMMARY

Director of Library Services and Community Outreach requests Board's authorization to accept a donation in the amount of \$3,000 from the Robert and Ellen Streich Family Endowment, a Legacy Fund of the Napa Valley Community Foundation. This donation will be used to purchase books and outreach materials for the adult literacy program of the Literacy Center at the Napa County Library.

In accordance with Board Resolution No.99-56, adopted on June 1, 1999, the Director of Library Services and Community Outreach must obtain authorization from the Board of Supervisors before accepting donations greater than \$2,000.

On February 1, 2022, the Library received a donation in the amount of \$3,000 from the Robert and Ellen Streich Family Endowment, a Legacy Fund of the Napa Valley Community Foundation. The Director of Library and Community Outreach seeks the Board's approval to accept the donation and for the Chair to sign a letter of appreciation in acceptance of the donation. The Robert and Ellen Streich Family Endowment donation will be used to purchase books and outreach materials for the adult literacy program at the Napa County Library Literacy Center.
