ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined in Section 15378 of the CEQA Guidelines, which define a project as an action, which has the potential for resulting in either a direct physical change in the environment or a reasonable foreseeable indirect physical change. A final EIR was prepared and certified by the Board of Supervisors on February 11, 2014 for the Napa County Jail Project (SCH#2013012072). The Final EIR analyzed the potential impacts resulting from the General Plan Amendment and was prepared in accordance with CEQA, the State CEQA Guidelines and the County's Local Procedures for Implement CEQA. No further environmental review is necessary.

BACKGROUND AND DISCUSSION

Pacific Gas and Electric Company (PG&E) requires a public utility easement be granted across the Napa County owned parcel (APN 046-370-021) to provide services to the Napa County Jail Replacement project. The easement deed was prepared per PG&E requirements and is approved as to form by Napa County Counsel. The attached access and utility map shows the easement locations across the County owned parcel. The easement deed is presented to the Board of Supervisors for granting and execution.
