Today's action requests approval of budget adjustment to increase appropriations in Fund 5060 Napa County Housing Authority, Subdivisions by \$23,130 with offsetting revenues from a generous donation by the St. Helena Farmworker Committee.

BACKGROUND AND DISCUSSION

Today's action approves budget adjustment to increase appropriations in Fund 5060 Napa County Housing Authority, Subdivisions 5060502 and 5060503, by \$23,130 with offsetting revenues from a generous donation by the St. Helena Farmworker Committee.

After a thorough review of current mattresses at the Mondavi and River Ranch Farmworker Centers, onsite management strongly recommends replacement of mattresses to help promote healthy accommodations for current and future lodgers.
