Responses to the Grand Jury's findings and recommendations contained within the report are due to the Presiding Judge by September 13, 2022 and will be presented to the Board of Supervisors for approval no later than August 9, 2022.

The Final reports on "Napa County Juvenile Hall: Good Facility, Dysfunctional Governance, Unused Beds, Outdated Program"; "The Napa County Airport Under the Radar: The Saga to Bring Napa's Airport Into the 21st Century" were received on June 21, 2022.
