EXECUTIVE SUMMARY

Board consideration of a resolution deleting the Vital Statistics fee schedule from Section III of the Board Policy Manual, Fees for Services Provided by County Departments and Agencies, Section 120.400-Vital Statistics Fees is requested.

Because the rates for Vital Statistics Fees are set HSC and Napa County has no discretion as to whether to charge these mandated fees, there is no need to publish these fees in Section III of the Board Policy Manual and staff requests that this section of the manual be deleted.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

The Health and Human Services Agency's (HHS) Public Health Vital Statistics Office (VSO) maintains birth and death statistics for County residents and issues birth, death and fetal death certificates, as well as permits for the disposition of human remains. Today's action will delete birth, death, fetal death certificate, and burial permit fees from Section 120.400 - Vital Statistics Fees because these rates are set by California Health and Safety Code (HSC) and Napa County has no discretion whether to charge these mandated fees

In addition to the State mandated birth certificate fee, the County charges an additional \$3 local fee for deposit into the Children's Trust fund per HSC 103625(b)(2).

The proposed fees are specifically exempt from the voting requirements of Article XIIC of the California Constitution because they are charges imposed for specific government services requested by payers, provided directly to the payers, and are not enjoyed by anyone who does not pay the charge. These charges do not exceed

reasonable costs to the government for providing the service or product.
