**RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, DESIGNATING  
LINEBARGER GOGGAN BLAIR & SAMPSON, LLP  
AS THE COUNTY FINANCIAL EVALUATION OFFICER**

**WHEREAS**, Chapter 15 of Division 2 of Title 3 of the Government Code (commencing with § 27750) provides that the Board of Supervisors of any county may designate a county officer, thereafter known as the County Financial Evaluation Officer, to make financial evaluations of defendant and other persons liable for reimbursable costs under the law; and

**WHEREAS**, a County Financial Evaluation Officer is authorized to make, among other things, financial evaluations and collect monies from criminal defendants represented at public expense pursuant to Penal Code Section 987.8 and pursuant to Chapter 15 of the Government Code; and

**WHEREAS**, Napa County adopted Resolution No. 02-187 on September 10, 2002, designating California Service Bureau as the County Financial Evaluation Officer for this purpose; and

**WHEREAS**, Napa County adopted Resolution No. 2019-57 on May 7, 2019, designating GC Services as the County Financial Evaluation Officer for this purpose; and

**WHEREAS**, Napa County would like to designate Linebarger Goggan Blair & Sampson, LLP as a County Financial Evaluation Officer in place of GC Services.

**NOW, THEREFORE, BE IT RESOLVED** that the Board hereby resolves as follows:

1. Linebarger Goggan Blair & Sampson, LLP is hereby designated as the County Financial Evaluation Officer for the purpose of making financial evaluations and collecting money from criminal defendants pursuant to Penal Code Section 987.8 and Chapter 15 of Division 2 of Title 3 of the Government Code (commencing with § 27750).
2. This resolution supersedes and replaces Resolution 2019-57.
