**AN ORDINANCE OF THE NAPA COUNTY BOARD OF SUPERVISORS,
STATE OF CALIFORNIA, AUTHORIZING AMENDMENT TO THE
CONTRACT BETWEEN NAPA COUNTY AND THE BOARD OF
ADMINISTRATION OF THE CALIFORNIA PUBLIC EMPLOYEES'
RETIREMENT SYSTEM TO PROVIDE FOR EMPLOYEE COST-SHARING
IN SPECIFIED AMOUNTS DURING SPECIFIED TIME PERIODS FOR
CLASSIC MEMBERS IN THE NAPA COUNTY UNREPRESENTED
MISCELLANEOUS MANAGEMENT, SAFETY MANAGEMENT, AND
CONFIDENTIAL GROUPS, FIRST AND SECOND TIER CLASSIC
PURSUANT TO GOVERNMENT CODE SECTION 20516**

The Napa County Board of Supervisors ordains as follows:

SECTION 1. An amendment to the contract (Napa County Agreement No. 1464) between Napa County and the Board of Administration of the California Public Employees' Retirement System (CalPERS) is hereby authorized, a copy of said amendment is attached hereto, marked as Exhibit "A," and by such reference is made a part hereof as though set out in full.

SECTION 2. The Chair of the Napa County Board of Supervisors is hereby authorized, empowered, and directed to execute said amendment for and on behalf of Napa County.

SECTION 3. This Ordinance shall take effect 30 days after its adoption.

SECTION 4. A summary of this Ordinance shall be published at least once 5 days before adoption and at least once before the expiration of 15 days after its passage in the *Napa Valley Register*, a newspaper of general circulation published in Napa County, together with the names of members voting for and against the same.
