

**RESOLUTION NO. 2026-**

**A RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, INCREASING RATES AND ESTABLISHING NEW FEES FOR THE COLLECTION AND DISPOSAL OF GARBAGE IN GARBAGE ZONE TWO**

**WHEREAS**, the California Integrated Waste Management Act of 1989 (Public Resources Code sections 40000 et seq.) requires local agencies to make adequate provision for diversion of 50% of recyclable solid waste from landfills and safe disposal of garbage generated within their jurisdictions; and

**WHEREAS**, in 2016, the California Legislature passed SB 1383, Short-lived climate pollutants: methane emissions: dairy and livestock: organic waste: landfills, adding Sections 39730.5, 39730.6, 39730.7, and 39730.8 to the Health and Safety Code, and adding Chapter 13.1 (commencing with Section 42652) to Part 3 of Division 30 of the Public Resources Code. The law requires local agencies to provide organics recycling collection services to residential and commercial sites and to monitor and enforce participant's diversion of recyclables from landfills; and

**WHEREAS**, under the provisions of Chapter 8.48 of the Napa County Code, Napa County ("County") has granted to Berryessa Garbage Service ("BGS") an exclusive franchise for the collection and disposal of recyclables, compostable organics, and garbage in Garbage Zone Two of the County, and has set rates associated with the collection and disposal services performed by BGS under the franchise; and

**WHEREAS**, in accordance with the provisions of the franchise agreement, BGS has applied to the Board for a review and revision of certain rates, and the Board finds there is a need to increase existing rates for collection of solid waste and recyclable materials; and

**WHEREAS**, Chapter 12.5 of Part 1 of Division 2 of Title 5 of the California Government Code (commencing with Section 54985) and Chapter 8 of Division 1 of Title 7 of the California Government Code (commencing with section 66016) authorize the County to establish fees to recover the cost of providing a service; and

**WHEREAS**, pursuant to Government Code section 66016, at least ten days prior to the date this resolution is to be considered, data was made available to the public indicating the amount of the fee, or estimated fee, required to provide the service for which the fee or service charge is levied and the revenue sources anticipated to provide the service; and

**WHEREAS**, pursuant to Government Code section 66016, at least fourteen days prior to the date this resolution is to be considered, notice was mailed to those persons who had requested same; and

**WHEREAS**, notice of the hearing on the proposed fee was published twice in the manner set forth in section 6062a as required by section 66018, subsection (a), of the Government Code; and

**WHEREAS**, in accordance with the provisions of the franchise agreement, BGS shall provide its customers in Garbage Zone Two with advance written notice of the approved rate adjustments at least thirty (30) days prior to the effective date of the rate adjustment.

**NOW, THEREFORE, BE IT RESOLVED** that the Napa County Board of Supervisors hereby increases the rates for the collection of recyclables and garbage and establishes new fees as listed in Exhibit "A," attached hereto and incorporated by reference herein, to commence on July 1, 2026.

**BE IT FURTHER RESOLVED** that the Board finds this resolution is categorically exempt from the California Environmental Quality Act pursuant to Title 14, California Code of Regulations, section 15273, subsections (a)(1) and (a)(2).
