**RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS,
STATE OF CALIFORNIA, REDUCING SPEED LIMITS ON PORTIONS
OF BUHMAN AVENUE AND COLD SPRINGS ROAD**

WHEREAS, Chapter 7 of Division 11 of the Vehicle Code establishes prima facie (default) speed limits applicable to various types or locations of roadways, but authorizes local agencies to establish different speed limits, in five mile-per-hour increments, at whichever speed limits are “found most appropriate to facilitate the orderly movement of traffic” and are “reasonable and safe,” and which are supported by engineering and traffic surveys; and

WHEREAS, Willdan Engineering conducted an engineering and traffic survey of various County roads and issued a report in February, 2020, which included recommendations to reduce the speed limits on portions of Buhman Avenue and Cold Springs Road that were not implemented at that time; and

WHEREAS, the County now desires to reduce the speed limits on portions of Buhman Avenue and Cold Springs Road in accordance with the 2020 engineering and traffic survey; and

WHEREAS, Chapter 10.04 of the Napa County Code allows the Board of Supervisors to change speed limits by resolution if the changes are supported by an engineering and traffic survey;

NOW, THEREFORE, BE IT RESOLVED by the Napa County Board of Supervisors that the Board hereby determines, declares, and adopts the following speed limit reductions, based on the engineering and traffic survey, which are most appropriate to facilitate the orderly movement of traffic, and are reasonable and safe:

1. Buhman Avenue from Congress Valley Road to Napa City Limit - from 45 mph to 40 mph.
2. Cold Springs Road from Las Posadas Road to End - from 35 mph to 25 mph.
