## AMENDMENT NO. 1 NAPA COUNTY AGREEMENT NO. 250309B

#### PROFESSIONAL SERVICES AGREEMENT

THIS AMENDMENT NO. 1 TO AGREEMENT NO. 250309B is made and entered into as of this \_\_\_\_\_ day of August, 2025, by and between Napa County, a political subdivision of the State of California, hereinafter referred to as "County," and Mead & Hunt, Inc. a Wisconsin corporation, whose business address is 1360 19<sup>th</sup> Hole Dr. Suite 200, Windsor, CA 95492, hereinafter referred to as "Consultant."

### **RECITALS**

WHEREAS, on February 4, 2025, County and Consultant entered into Agreement No. 250309B ("Agreement") for Consultant to provide design engineering services for the Runway 6-24 PCC Joint Rehabilitation Project at the Napa County Airport; and

WHEREAS, due to delays in receiving confirmation from the FAA that the project would be eligible for grant funding, County will not be proceeding with the construction phase at this time; and

WHEREAS, County desires to compensate Consultant for some extra work they performed at County's request and to remove construction bid support from the scope of services because construction will not proceed at this time; and

**WHEREAS**, additional design services are needed to complete an emergency repair on Runway 6-24 lighting;

**NOW, THEREFORE,** for good and valuable consideration, the sufficiency of which is hereby acknowledged, County and Consultant hereby amend Agreement No. 250309B as follows:

#### **TERMS**

- 1. Paragraph 1.1 of the Agreement is amended to read as follows:
  - 1.1 Scope of Services. Consultant shall provide professional services to County as described in Exhibit A to this Agreement, as modified by Exhibit A-1 to this Agreement, and in accordance with the Contract Documents. The Contract Documents consist of this Agreement and any amendments thereto, their Exhibits, the Request for Proposals or Qualifications issued by County (if any), and Consultant's proposal or statement of qualifications.
- 2. Paragraph 3.1 of the Agreement is amended to read as follows:
  - **3.1** Amount of Compensation. County shall pay Consultant for satisfactory performance of the scope of services, as follows:

- **3.1.1** Rates. County shall pay Consultant according to the phases and compensation and fee schedule set forth in Exhibit B, as modified by Exhibit B-1.
- **3.1.2** Expenses. Travel or other expenses will only be reimbursed by County if such expenses are specifically identified in Exhibit B. Any travel expenses must comply with the Napa County Travel Policy found in the Napa County Policy Manual, Part I, Section 43, regardless of anything to the contrary in Exhibit B.
- **3.1.3 Maximum Amount.** Notwithstanding paragraphs 3.1.1 and 3.1.2, the maximum payments under this Agreement shall not exceed a total of Eighty Thousand, Seven Hundred Dollars and Zero Cents (\$80,700.00) provided, however, that such amounts shall not be construed as guaranteed sums, and compensation shall be based upon services actually rendered and reimbursable expenses actually incurred.
- 2. Exhibits A-1 and B-1 attached to this Amendment No. 1 are hereby incorporated into the Agreement.
- 3. This Amendment No. 1 represents all the changes to the Agreement agreed to by the parties. No enforceable oral representations or other agreements have been made by the parties except as specifically stated herein. All other provisions of the Agreement not addressed in this Amendment No. 1 shall remain in full force and effect.
- 4. This Amendment No. 1 may be executed in counterparts which, when taken together, shall constitute a single signed original as though all parties had executed the same page. This Amendment may be executed by facsimile or electronic (.pdf) signature and shall constitute an original for all purposes.

The Compensation and Fee Schedule set forth in Exhibit B to the Agreement is hereby modified as set forth herein:

This Amendment is for the removal of the Bid Administration work efforts in Phase 3 and adding a Phase 4 for Emergency Threshold Lighting Repair on Runway 6-24. This Amendment results in an increase to the total Project cost of Nine Thousand Two Hundred Sixty-Eight Dollars (\$9,268), as shown on the table below. This Amendment results in a revised contract amount of \$80,700 for the total Project.
