

**NAPA COUNTY RESOLUTION NO. 2025-\_\_\_\_\_**

**RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS,  
STATE OF CALIFORNIA, PROCLAIMING THE TERMINATION OF THE  
STATE OF LOCAL EMERGENCY ISSUED IN RESPONSE TO  
THE FEBRUARY 2025 STORMS**

**WHEREAS**, on February 14, 2025, pursuant to Government Code section 8630 and Napa County Code section 2.80.060, subd. (A)(2), Napa County Executive Officer/ Director of Emergency Services issued a Proclamation of Local Emergency in Napa County as a result of a severe storms that occurred starting February 4, 2025 (referred to as the “February 2025 Storms”); and

**WHEREAS**, on February 18, 2025, the Board of Supervisors proclaimed a state of local emergency throughout Napa County as a result of the February 2025 Storms; and

**WHEREAS**, on April 8, 2025, the Board of Supervisors continued the state of emergency; and

**WHEREAS**, pursuant to California Government Code section 8630, subd. (c), local agencies normally must revisit a state of local emergency every 60 days; and

**WHEREAS**, pursuant to California Government Code section 8630, subd. (d), local agencies must terminate a state of local emergency once conditions warrant; and

**WHEREAS**, Napa County is no longer relying on the state of local emergency; and

**NOW, THEREFORE, BE IT RESOLVED** by the Napa County Board of Supervisors, that the state of local emergency due to the February 2025 Storms is hereby terminated.
