#### 8. BOARD OF SUPERVISORS REPORTS AND ANNOUNCEMENTS

Chair Cottrell announced that if anyone was at the Board Meeting regarding adopting an ordinance to add a section to the County Code concerning nuisance abatement procedures, that item was removed by the CEO and redirected back to the department for further consideration and was not on agenda. Chair Anne Cottrell acknowledged the passing of renowned vintner Carl Doumani, who founded Stag Leaps and Quixote Wineries. Carl was one of a kind who lived boldly, mentored generously, and challenged the status quo. Later in life, he became quietly philanthropic supporting causes close to his heart, including Providence Napa Valley. Condolences were offered to his family and friends. Chair Cottrell also reported on testifying last Wednesday on AB 470, which is sponsored by AT&T to remove its responsibility for being a carrier of last resort. The bill moved forward, and if it should pass, it will negatively impact rural counties and underserved urban sections of many counties. Lastly, Chair Cottrell requested an update on the Napa Valley Tourism Corporation in May or June on the efforts related to agreements between the Napa Valley Tourism Corporation and Visit Napa Valley, the Napa Valley Tourism Corporation and Napa County, as well as updating the bylaws and other documents.

Vice-Chair Amber Manfree acknowledged attending many recent community events with her colleagues. Vice-Chair Manfree also reported Golden Mussels were found on a boat in Lake Berryessa, but it had been out of the water for some time, and DNA analyses performed at different parts of the lake all came back negative. This is an example of the importance of efforts to control the invasive species.

Supervisor Joelle Gallagher recognized revenue sources on today's consent agenda. The CSA No. 4 assessment provides critical support for farmworker housing. Other sources, such as the annual Cinco de Mayo golf tournament, in its 25th year, raised \$100,000 last Friday for farmworker housing. The Winegrape Pest and Disease assessment directly benefits the ag industry and impacts the local economy by preventing the invasion and spread of destructive disease through pests. Supervisor Gallagher also reported on attending the graduation ceremony of 17 new Napa County firefighters.

Supervisor Liz Alessio reported on attending last week's California Association of Counties (CSAC) legislative conference with some of her colleagues. Discussions focused on key issues facing difficult state budgeting challenges that will impact all counties. There was an impromptu invitation to join Senator Chris Cabaldon's Finance Budget Review Committee, which had a discussion on the Vehicle License Fee (VLF) and Educational Revenue Augmentation Fund (ERAF). Supervisor Alessio also reported on attending the Walk-A-Mile and Napa Valley Education Foundation Taste for Knowledge events, and a tour with Agricultural Commissioner and Sealer of Weights and Measures Tracy Cleveland. Lastly, Supervisor Alessio requested staff to look into the azolla water fern that appears to be taking over Lake Marie at Skyline Park.

Supervisor Belia Ramos acknowledged her colleagues who also attended the CSAC legislative conference, where she provided testimony on the VLF. CSAC commissioned a report that described realignment, and Supervisor Ramos worked with Sheriff Oscar Ortiz on highlighting tremendous unfunded mandates affecting many levels of administration of justice, as well as health and human services. An important point to carry to the forefront of discussions regarding the General Fund and the impacts of VLF being 15% of discretionary funds is everything that comes from the state comes with a cost. Supervisor Ramos will continue to provide updates to the Board and is able to obtain copies of the report for those who are interested.
