RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, APPROVING SUCCESSOR MEMORANDA OF UNDERSTANDING FOR THE DEPUTY SHERIFFS' ASSOCIATION UNIT AND DEUTY SHERIFFS' ASSOCIATION SUPERVISORY UNIT, EFFECTIVE OCTOBER 1, 2025

WHEREAS, Government Code section 25300 provides that the Board of Supervisors shall provide for the number, compensation, tenure, appointment and conditions of employment of county employees and that such action may be taken by ordinance or resolution; and

WHEREAS, the Memoranda of Understanding (MOU) between Napa County (County) and Deputy Sheriffs' Association (DSA) Law Enforcement Unit and Law Enforcement Supervisory Unit expired on September 30, 2025; and

WHEREAS, County entered into negotiations with DSA to establish successor MOU for the Law Enforcement Unit and the Law Enforcement Supervisory Unit; and

WHEREAS, County and DSA reached Total Tentative Agreements that were ratified by DSA membership and approved by the Board of Supervisors on October 21, 2025; and

WHEREAS, the Total Tentative Agreements' terms have been incorporated into successor MOUs, effective October 1, 2025, and expiring September 30, 2028; and

WHEREAS, the successor MOUs for the DSA are set forth in Exhibits "A" and "B," attached hereto.

NOW, THEREFORE, BE IT RESOLVED that the Napa County Board of Supervisors hereby approves successor MOUs for the DSA Law Enforcement Unit and Law Enforcement Supervisory Unit, as set forth in Exhibits "B" and "C," respectively, with an effective date of October 1, 2025, and expiring September 30, 2028.
