## NAPA COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT AMENDMENT NO. 2 TO AGREEMENT NO. 220222B (FC)

THIS AMENDMENT NO. 2 TO NAPA COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT AGREEMENT NO. 220222B (FC) ("Agreement") is made and entered into effect as of this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 2024, by and between the Napa County Flood Control and Water Conservation District, a special district of the State of California ("DISTRICT"), and Sonoma RSA, Inc., a California Corporation dba RSA+, whose mailing address is 1515 4<sup>th</sup> Street, Napa, California 94559 ("CONTRACTOR").

## **RECITALS**

**WHEREAS**, on January 4, 2022, DISTRICT and CONTRACTOR entered into the Agreement for specialized surveying services for the Napa River/Napa Creek Flood Protection Project, as directed by the DISTRICT; and

**WHEREAS**, on August 22, 2023, DISTRICT and CONTRACTOR signed Amendment No. 1, increasing the maximum compensation ONE HUNDRED AND FIFTY THOUSAND DOLLARS (\$150,000) to a total of THREE HUNDRED THOUSAND DOLLARS (\$300,000); and

**WHEREAS**, DISTRICT anticipates the need for additional specialized surveying services to support the design and construction of the Napa River/Napa Creek Flood Protection Project (Project) as well as other District projects on an as needed basis; and

**WHEREAS**, CONTRACTOR is willing to continue to provide such specialized surveying services, as directed by DISTRICT; and

**WHEREAS**, DISTRICT and CONTRACTOR now desire to modify the provisions of the Agreement to increase the maximum compensation by ONE HUNDRED THOUSAND DOLLARS (\$100,000) to a new total of FOUR HUNDRED THOUSAND DOLLARS (\$400,000).

## **TERMS**

**NOW, THEREFORE** DISTRICT and CONTRACTOR hereby agree to amend the Agreement as follows:

- 1. Paragraph 3(b) of the Agreement is hereby amended to read as follows:
  - Expenses. No travel or other expenses will be reimbursed by DISTRICT.
- 2. Paragraph 3(c) of the Agreement is hereby amended to read as follows:

<u>Maximum Amount</u>. Notwithstanding subparagraphs (a) and (b), the maximum payments under this Agreement shall not exceed a total of FOUR HUNDRED THOUSAND DOLLARS (\$400,000) for professional services; provided, however, that such amounts

- shall not be construed as guaranteed sums, and compensation shall be based upon services actually rendered actually incurred.
- 3. This Amendment No. 2 shall be effective as of the Effective Date first set forth above.
- 4. Except as provided in (1), (2), and (3) above, the terms and provisions of the Agreement shall remain in full force and effect as last approved.
- 5. This Amendment No. 2 may be executed in counterparts, which when taken together, shall constitute a single signed original as though all parties had executed the same page.
