## **EMERGENCY ACCESS EASEMENT DEED**

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, Napa County Land Trust, a California nonprofit organization doing business as The Land Trust of Napa County, hereinafter referred to as "GRANTOR," hereby GRANTS to Napa County, a political subdivision of the State of California, hereinafter referred to as "GRANTEE," a permanent easement and a right of way for emergency access ("Easement"), subject to limitations set forth below, forty (40) feet in width, the center line of which is along the existing roadway, with the right of ingress and egress of emergency vehicles for access over the property on the land described in Exhibit A attached hereto and made a part hereof by this reference (the "Easement Area"). Provided, however, the existing roadway shall not be widened or improved beyond what may be required under the Napa County Road and Street Standards ("Road Standards").

GRANTOR hereby covenants and agrees that no structures shall be constructed, erected, or placed upon the Easement Area that would materially impair the normal operation or use of the Easement Area for emergency vehicular purposes. GRANTOR hereby covenants and agrees that it will not place or allow to be placed any permanent structures or trees within the area described for this Easement, which would interfere with the use of said Easement, for the purposes stated herein.

GRANTEE hereby covenants and agrees to contain any vegetative maintenance of the Easement of at least ten (10) feet from the edges of the existing roadway, except to the extent necessary according to the Road Standards or as otherwise required by law. GRANTEE hereby agrees to employ methods that minimize impacts outside of the Easement Area, including utilization of manual maintenance methods.

This instrument shall bind and inure to the benefit of the successors and assigns of the parties hereto.

BEGINNING at a rebar and cap stamped LS 4510 at the most southerly corner of the lands of the Rachael Balyeat Revocable Trust as shown on Map No. 4449 filed February 13, 1991 in Book 27 of Surveys at pages 100 and 101 in the office of the Napa County Recorder, said rebar being on the southwesterly line of the Catacula Rancho; thence along said Rancho line South 50°16'26" East 8.50 feet to a point on the centerline of an existing dirt road; thence leaving said Rancho line South 40°29'00" West 60.00 feet; thence continuing along the center of said road the following courses: South 40°29'00" West 3.15 feet, along a curve to the left having a radius of 400.00 feet through a central angle of 7°38'53" an arc length of 53.39 feet, South 32°50'07" West 199.09 feet, along a curve to the right having a radius of 65.00 feet through a central angle of 77°52'41" an arc length of 88.35 feet, North 69°17'12" West 134.38 feet, along a curve to the left having a radius of 250.00 feet through a central angle of 62°15'08" an arc length of 271.63 feet, South 48°27'40" West 163.71 feet, along a curve to the left having a radius of 210.00 feet through a central angle of 18°04'59" an arc length of 66.28 feet and South 30°22'40" West 53.49 feet, along a curve to the left having a radius of 100 feet through a central angle of 49°56'56" an arc length of 87.18 feet, South 19°34'16" East 15.29 feet, along a curve to the left having a radius of 50.00 feet through a central angle of 77°56'25" an arc length of 68.02 feet, North 82°29'19" East 42.05 feet, along a curve to the right having a radius of 60.00 feet through a central angle of 59°41'25" an arc length of 62.51 feet, South 37°49'16" East 96.83 feet, along a curve to the right having a radius of 50.00 feet through a central angle of 124°34'26" an arc length of 108.71 feet, South 86°45'10" West 22.18 feet, along a curve to the left having a radius of 50.00 feet through a central angle of 133°47'29" an arc length of 116.76 feet, South 47°02'19" East 1.05 feet, along a curve to the right having a radius of 80.00 feet through a central angle of 43°38'05" an arc length of 60.93 feet, South 3°24'14" East 47.93 feet, along a curve to the right having a radius of 180.00 feet through a central angle of 12°07'35" an arc length of 38.10 feet, South 8°43'21" West 21.03 feet, along a curve to the left having a radius of 55.00 feet through a central angle of 47°19'42" an arc length of 45.43 feet and South 38°36'22" East 15.78 feet to the true point of beginning of this description; thence continuing along said centerline southwesterly 1500 feet more or less to the south line of said north half of the northeast quarter of Section 10, Township 8 North, Range 5 West, Mount Diablo Meridian, extending or shortening the sidelines of said 20 foot wide strip so as to provide a continuous strip of land from the southerly terminus of the 15.78 foot course called herein to the south line of the north half of the northeast quarter of said Section 10.
