HHSA BEHAVIORAL HEALTH TREATMENT CENTER BACKGROUND

- <u>Proposal</u>: In 2024, HHSA Proposed Repurposing the "Reentry Facility" to a "BH Treatment Center"
- <u>Opportunity</u>:
 - Makes Strategic Use of a Unique and Existing Facility in our County
 - Creates Behavioral Health Infrastructure to Sustain/Expand Treatment
- <u>Challenge</u>: Legally Restricted as a "Reentry Facility" Due to SB 1022 Bond & Legal Complexities
- Actions (Last 10 Months):
 - Architectural Feasibility/Design Completed; Relatively Minimal Modifications Needed
 - Significant Due Diligence Explored Legal/Funding Alternatives to Remove Restrictions
 - SB 1022 Bond Defeasance \rightarrow Paves the Way for "Behavioral Health Treatment Center" Project

BLUE = SB43 LPS FACILITY (MHRC OR OTHER LICENSE TYPE)


GREEN = SOBERING CENTER

HHSA BEHAVIORAL HEALTH TREATMENT CENTER PROGRAMS/SERVICES OVERVIEW

- Facility Over 21K Square Feet; Maximize Use of Space; Create 3 Distinct Areas
- 1 Residential Treatment/Withdrawal Management
 - Currently Located on Grounds of Napa State Hospital
 - Investment in Long-Term Facility for Program to Continue Operating
 - New Proposition 36 Mandate Expanded Treatment Capacity Needs
- 2 SB 43 Lanterman-Petris-Short (LPS) Facility
 - Mental Health Rehabilitation Center (MHRC) or Other License Type
 - New SB 43 Mandate Significant Change in 50 Years to LPS Conservatorship Law
 - Expansion of "Grave Disability" to Include Severe Substance Use Disorders or Co-Occurring MH/SUDS
- 3 Sobering Center
 - Emergency Department and Jail/Law Enforcement Diversion; Short-Term <24 Hour
 - Point for Early Intervention; Screening for Referral Pathways to Treatment and Community Resources
 - Newly Reimbursable under CalAIM

- Facility Modifications: Continue Sequenced Work with Public Works and Nacht & Lewis
 - Current Timeline for Construction Modifications Completion June 2026
 - Timeline Sequenced to Moving Probation to New Location
- Seek BHCIP Grant Funding ~ New Opportunity
- Continue Work on Associated Programming in Meeting Mandates
- Issue Request for Proposal for Providers for Various Programs/Services
