Please explain your reasons for wishing to serve and, in your opinion, how you feel you could contribute.

I am an elected official in Yountville, serving on a Town Council that represents a community whose average age is 64.5, and trending upwards. The Town faces mobility and housing affordability issues - especially since many of our seniors are (or will be) downsizing to age-in-place. As the Town is actively working on housing solutions, I am lobbying for affordable homes for seniors who wish to downsize, and I want that housing to be combined with much-needed workforce housing because I believe it will support a richer fabric that strengthens the community. Yountville is also a designated Blue Zone community, so I give full support to programs for seniors to keep them active, healthy and engaged. I also serve as a board member on NVTA, where we are looking at how senior transportation can be more readily available and affordable throughout the valley. As a resident in Yountville, and in particular, a 55+ manufactured home (mobile home) community, I am a friend and neighbor to many who are "aging in place". My immediate neighbors range from 75-98 years in age. Homes here, and in many similar communities, are master metered - so no one is billed directly for utilities by PG&E. Because of this, there are many who "fall through the cracks" since they do not show up in PG&E's low-income demographic, which many agencies use for discount program qualification purposes. This is an issue I want to address and tackle within this commission, should I be selected for the role. Lastly, I work and volunteer my time in senior living establishments such as the Yountville Veterans Home, Aegis Living and Holiday Redwood Retirement Residence, and with Molly's Angels. As a vocalist, I use music to connect with seniors and to help them keep youthful memories alive.
