RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS, STATE OF CALIFORNIA, AMENDING THE BYLAWS OF THE AIRPORT ADVISORY COMMISSION

WHEREAS, on June 24, 1969, the Napa County Board of Supervisors ("Board") adopted a resolution creating the Napa County Airport Advisory Commission ("Commission") and adopting policies to govern various aspects of the Commission; and

WHEREAS, these policies have been incorporated into Part II: Section 3 of the Napa County Policy Manual; and

WHEREAS, the Airport Advisory Commission Bylaws were amended on August 19, 1997 by Resolution No. 97-91, and

WHEREAS, the Airport Advisory Commission Bylaws were amended a second time on May 7, 2019 by Resolution No. 2019-54; and

WHEREAS, Public Works, County Counsel, and Airport staff, have developed a set of amendments to the Commission bylaws to clarify participation, establish better continuity in the terms of Commissioners, and align the conduct of Commission business to the Board policies; and

WHEREAS, at its October 6, 2025 meeting, the Airport Advisory Commission voted in support of the recommended amendments to the bylaws.
