RESOLUTION OF THE BOARD OF SUPERVISORS OF NAPA COUNTY, STATE OF CALIFORNIA, APPROVING THE EXECUTION OF AN AGREEMENT WITH THE CALIFORNIA SECRETARY OF STATE FOR STATE FUNDING TO REIMBURSE COUNTIES FOR VOTING SYSTEM REPLACEMENT

WHEREAS, the California legislature has appropriated funds by Assembly Bill 1824, Chapter 38 (Stats.2018) and Assembly Bill 74, Chapter 23 (Stats.2019), (Voting System Replacement Contracts) pursuant to California Elections Code sections 19400 and 19402; and

WHEREAS, the California Secretary of State administers these state funds to reimburse counties for voting system replacement activities; and

WHEREAS, Napa County is eligible for Forty Eight Thousand Seven Hundred Eighty-Five Dollars (\$48,785) for voting system replacement purchased in 2025; and

WHEREAS, procedures established by the California Secretary of State require the County to certify by resolution the approval of the agreement for distribution of said funds to Napa County.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Napa County as follows:

1. The Board authorizes the execution of Agreement 25G31033 with the California Secretary of State for voting system replacement activities.
2. The Board hereby approves said Agreement, attached to this Resolution as Exhibit A, and authorizes the Chair to sign it.
3. The Board certifies that the County, through its Registrar of Voters, understands the funding application, and/or terms of the Agreement, including the assurances and certification therein.
4. The Board appoints the Assessor-Recorder-County Clerk ex-officio Registrar of Voters as agent to conduct all negotiations, execute and submit all documents, other than the initial contract or any amendments thereto, including but not limited to applications, payment requests and other documentation, which may be necessary for the fulfillment of the duties and responsibilities under the Agreement.
