PROFESSIONAL SERVICES AGREEMENT

THIS AMENDMENT NO. 1 ("Amendment No. 1) of NAPA COUNTY

AGREEMENT NO. 240285B is made and entered into as of this 11th day of June 2024, by and between NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and GHD. INC. a California corporation, whose mailing address is 2235 Mercury Way, Suite 150, Santa Rosa, CA 95407, hereinafter referred to as "CONTRACTOR."

RECITALS

WHEREAS, COUNTY entered into Napa County Agreement No. 240285B with CONTRACTOR on February 27, 2024 ("Agreement"), to obtain specialized services, as authorized by Government Code section 31000, in order to provide engineering design and support services for the North County Crossroads Paving Project, RDS 24-08 ("Project"); and

WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement to increase the scope and compensation in order to provide engineering design and support services for the Project.

TERMS

NOW, THEREFORE, COUNTY and CONTRACTOR hereby amend the Agreement as follows:

1. Paragraph 2 of the Agreement is amended to read in full as follows:

Scope of Services. CONTRACTOR shall provide COUNTY those services set forth in Exhibit "A," attached to this Agreement as originally approved, and those additional services set forth in Exhibit "A-1," attached to Amendment No. 1 of the Agreement, said Exhibits being incorporated by this reference herein.

2. Paragraph 3, subparagraph (c), of the Agreement is amended to read in full as follows:

<u>Maximum Amount.</u> Notwithstanding subparagraphs (a) and (b) or any other provision of this Agreement, the maximum payments under this Agreement shall be **Five Hundred Seventy-Two Thousand Four Hundred Thirty-Eight AND 00/100 DOLLARS** (\$572,438); provided, however, that such amounts shall not be construed as guaranteed sums, and compensation shall be based upon services actually rendered and reimbursable expenses actually incurred. 3. Except as provided in paragraphs (2) and (3), above, all other provisions of the Agreement shall remain in full force and effect as previously approved.

IN WITNESS WHEREOF, COUNTY and CONTRACTOR have executed this Amendment No. 1 to Napa County Agreement No. 240285B as of the date first above written.

SCOPE OF WORK

The CONTRACTOR will provide COUNTY with the following additional services for the North County Crossroads Paving Project, RDS 24-08:

- Consultation and Construction Observation and Testing
 - Preconstruction meetings.
 - Review submittals and/or RFIs as necessary.
 - Site visits to observe, test, and sample materials.
 - Density testing on the baserock backfill of the new culvert on Tubbs Lane.
 - Density testing of asphalt.
 - Laboratory asphalt testing.
 - Report with a summary of test results and conformity to Caltrans requirements and project specification.
