

**AMENDMENT NO. 2
NAPA COUNTY AGREEMENT NO. 220310B
PROFESSIONAL SERVICES AGREEMENT**

THIS AMENDMENT NO. 2 OF NAPA COUNTY AGREEMENT NO. 220310B, is made and entered into as of this 10th day of March, 2026, by and between NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as the “COUNTY” and Granicus, whose mailing address is 408 Saint Peter Street, Suite 600, Saint Paul, MN, 55102, hereinafter referred to as “CONTRACTOR”;

RECITALS

WHEREAS, COUNTY and CONTRACTOR entered into Napa County Agreement No. 220310B (the “Agreement”) on January 3, 2022, to provide monitoring, analytic, and compliance software and related services for the detection and management of illegal, unpermitted and/or under-remitting short term rentals; and

WHEREAS, COUNTY and CONTRACTOR executed Amendment No. 1 to the Agreement on July 1, 2024 for the purposes of extending the Term; and

WHEREAS, COUNTY and CONTRACTOR now wish to amend the Agreement to further extend the term.

TERMS

NOW, THEREFORE, the Agreement is amended as follows:

1. Paragraph 1 is hereby amended to read in full as follows:
 1. **Term of the Agreement.** The term of this Agreement shall commence on July 1, 2025 and shall expire on October 20, 2025, except that the obligations of the parties under Paragraphs 7 (Insurance) and 8 (Indemnification) shall continue in full force and effect after said expiration date or early termination in relation to acts or omissions occurring prior to such dates during the term of the Agreement, and the obligations of CONTRACTOR to COUNTY shall also continue after said expiration date or early termination in relation to the obligations prescribed by Paragraphs 15 (Confidentiality), 20 (Taxes) and 21 (Access to Records/Retention).
2. **Counterparts.** This Amendment No. 2 may be executed in counterparts, which when taken together, shall constitute a single signed original as though all parties had executed the same page.
3. **Electronic Signatures.** This Amendment No. 2 may be executed by electronic signature(s) and transmitted in a portable document format (“PDF”) version by email and such electronic signature(s) shall be deemed original for purposes of this Amendment No. 1 and shall have the same force and effect as a manually executed original.

- 4. This Amendment No. 2 shall be effective as of July 1, 2025.
- 5. Except as provided herein, the terms and provisions of the Agreement shall remain in full force and effect.
