The funding that comes through the Area Agency on Aging is critical in managing how it is best used. I am asking for the opportunity to be part of that process. I bring to this process my experience and knowledge obtained as Director of Criminal Justice Planning for Napa County, managing the resources of local non-profits, dealing with the various funding streams for County Mental Health services, and managing a large county budget as Director of Corrections for Napa County.
