**RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS,
STATE OF CALIFORNIA, AUTHORIZING ADOPTION OF THE NAPA
COUNTY BEHAVIORAL HEALTH SERVICES ACT THREE-YEAR
INTEGRATED PLAN FOR FISCAL YEARS (FY) 2026-2029**

WHEREAS, the Behavioral Health Services Act (BHSA) was passed through a ballot initiative (Proposition 1) in 2024 and provides funding to support county behavioral health programs; and

WHEREAS, the BHSA specifies three major program components (Full Service Partnerships, Behavioral Health Services and Supports, and Housing Interventions) for which funds may be used and the percentage of funds to be devoted to each component; and

WHEREAS, In order to access BHSA funding from the State, counties are required to 1) develop a Three-Year Program and Expenditure Plan (Integrated Plan), and Annual Updates, in collaboration with stakeholders; 2) post each plan for a 30-day public comment period; and 3) hold a public hearing on the plan with the County Behavioral Health Advisory Board; and

WHEREAS, Napa County conducted its Public Comment period from April 1, 2026 to May 1, 2026, culminating in a Public Hearing held on May 13, 2026, and incorporated stakeholder feedback into the BHSA planning process; and

WHEREAS, the Napa County BHSA Integrated Plan FY2026-2029, which is hereby declared to be a part of this Resolution as if set forth fully herein, complies with the BHSA requirements above, and provides an overview of a three-year plan, various components, and an expenditure plan for Napa County for FY2026-2029.

NOW, THEREFORE, BE IT RESOLVED by the Napa County Board of Supervisors as follows:

1. Approve and adopt Napa County Behavioral Health Services Act Integrated Plan for FY 26–27 to FY 28–29.
2. Health and Human Services Agency Director is authorized to make non-substantive revisions to the Integrated Plan if further revisions are requested by the Department of Health Care Services.
