7. BOARD OF SUPERVISORS REPORTS AND ANNOUNCEMENTS

Supervisor Joelle Gallagher acknowledged the brutality and loss due to immigration enforcement. She urged members of the public to speak against these acts. She thanked the residents of Napa County who have participated in various displays of acknowledgement against these acts.

Vice-Chair Liz Alessio congratulated Jeni Olsen on becoming the Executive Director of Cope Family Center. She then reported on attending the Napa Chamber of Commerce reception where they released information on the Economic Development Strategy and requested the Board receive an economic update specific to Napa County from Dr. Robert Eyler. Next, Vice-Chair Alessio congratulated Supervisor Anne Cottrell on her job as a panelist for the Latino Leaders Roundtable event. Vice-Chair Alessio also attended the Cultivar 360 Academy graduation and congratulated the graduates. Next, she provided updates on the Marin Clean Energy (MCE) meeting, one being her appointment to the Finance Committee and secondly, the ad hoc Governance Assessment Committee where they discussed a review of the structure of the organization. Next, a referral was presented to the Chief Executive Officer (CEO) to come back with a letter of support for SB299 and have all Board Members sign it. Next, Vice-Chair Alessio reported on convening a roundtable event in support of utility companies working together while undergrounding. Next, she provided an update from the Napa Valley Transportation Authority (NVTa) meeting where she requested staff to come back with a pilot program for a Mobility Manager. Lastly, she reported on a book written by John S. McCormick titled "Chinese in Napa Valley: The Forgotten Community That Built Wine Country". There will be a documentary released on Monday, February 2, 2026 at 5:00pm at the Cameo Cinema movie theater in St. Helena, CA.

Supervisor Belia Ramos thanked Supervisor Joelle Gallagher for her comments and then reported on her moderation of a panel in collaboration with the League of Woman's Voters called "Building Bridges Not Barriers". During this panel they discussed the school district and nonprofit partners support for immigrant communities and providing safe paths. Supervisor Ramos then reported on being a Director at the Bay Area Latino Elected and Appointed Officials Organization and taking a trip to Stanford University where they heard about immigration policies and briefings and how they relate to local governments. Next, Supervisor Ramos congratulated Supervisor Anne Cottrell on her role as Second Vice-Chair of Rural County Representatives of California (RCRC). Next Supervisor Ramos invited the public to the Napa River Ecology Center Winter Open House from 4:00pm to 6:00pm on January 29, 2026. Also, the American Canyon Library is reopening on Saturday, January 31, 2026. Next, Supervisor Ramos noted her participation in the Wetlands Cleanup event in American Canyon and made a referral requesting a letter of support be sent to the Senate supporting the expedited rule making for the Climate Bond issuance dollars of Prop 4. Lastly, she encouraged members of the public to visit the Napa County Law Library.

Supervisor Anne Cottrell expressed her gratitude for the Board's decision to adjourn in memory of Renee Nicole Good and Alex Pretti and provided a statement and expressed gratitude to other Supervisors for their comments. Supervisor Cottrell reported that she will be chairing an ad hoc committee with RCRC on sustainable groundwater management. Lastly, she called out multiple items approved in the consent calendar of the agenda.

Chair Amber Manfree concurred with her fellow Board members statements regarding national events. She then provided her own statement detailing various available resources to the public.
