

**SIXTH AMENDMENT TO NAPA COUNTY AGREEMENT NO. 170123B
(PREVIOUSLY AGREEMENT NO. 8053)**

PROFESSIONAL SERVICES AGREEMENT

THIS SIXTH AMENDMENT to Agreement No. 170123B is made this 22nd of July 2025, by and between NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as “COUNTY,” and CLAREMONT BEHAVIORAL SERVICES, INC., doing business as Claremont EAP, licensed as Knox-Keene specialized health plan, whose mailing address is 1050 Marina Village Parkway, Suite 203, Alameda, California, 94501, hereinafter referred to as “CONTRACTOR.”

TERMS

WHEREAS, on January 1, 2014, COUNTY engaged CONTRACTOR in Agreement No. 170123B (previously Agreement No. 8053) to establish an Employee Assistance Program (EAP) for the benefit of its employees and their dependents; and

WHEREAS, on January 1, 2016, COUNTY and CONTRACTOR amended the Agreement to change the term, rates as set forth in Exhibit “C-1”, and amount of maximum compensation; and

WHEREAS, on October 4, 2016, COUNTY and CONTRACTOR amended the Agreement to increase the maximum compensation; and

WHEREAS, on February 1, 2019, COUNTY and CONTRACTOR amended the Agreement to add the services set forth in Exhibits “A”, “A-1”, and “B”; and

WHEREAS, on November 2, 2021, COUNTY and CONTRACTOR amended the Agreement to add the services set forth in Exhibit “D,” and

WHEREAS, on November 28, 2023, COUNTY and CONTRACTOR amended the Agreement to add the services set forth in Exhibits “A-2”and “C-2,”

NOW THEREFORE COUNTY and CONTRACTOR wish to further amend Agreement No. 170123B as follows:

1. As of the effective date of the Amendment, Paragraph 3 (c), “Compensation,” is amended to read in full, as follows:

(c) Maximum Amount. Notwithstanding subparagraphs (a) and (b), the maximum payments under this Agreement per fiscal year shall be a total of ONE HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$125,000) for professional services; provided, however, that such amounts shall not be construed as guaranteed sums, and compensation shall be based upon services actually rendered.

2. All other terms and conditions of Agreement No. 170123B shall remain in full force and effect.

IN WITNESS THEREOF, the parties have executed this Sixth Amendment to Agreement No. 170123B on July 22, 2025.
