# farmworker centers known as the River Ranch Center, Mondavi Center, and Calistoga Center.

Santino Garcia, CHDC COO, and Dan Walker, CHDC CFO, presented CHDC Fiscal Year 2025 budget. The proposed budget and contract with CHDC includes an increase from prior fiscal year of 5%, reflecting operational increases in information technology, fringe benefits, and insurance, for example. CHDC will operate to provide 18,810 bed nights for farmworkers at each of the three centers. Opening and closing schedule:
