Kelli,

We are working to have the document removed from the SCH. I do want to give some context on CDFW's decision to rescind this letter.

CDFW maintains this area is near potential nesting habitat for the state threatened Swainson's hawk due to large trees in the area, proximity to foraging habitat, and recent confirmed nesting near Suscol Creek. After a site visit it was determined that the impacts from the project associated with septic system installation, the addition of a porch, and the construction of six small structures was negligible due to visual obstructions of potential nest trees and similar noise and activity levels from nearby properties.

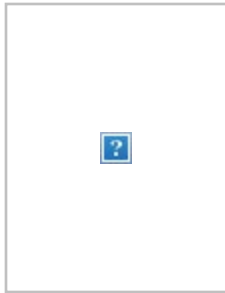
