I wanted to follow up after our meeting earlier this week. Thank you for taking the time to meet with Jason and myself to discuss the applicability of SOI applications in relation to the Airport Land Use Compatibility Plan. I know in our discussions you had mentioned that were satisfied with our explanation that LAFCO itself is not subject to ALUC review, but that SOI applications that come through LAFCO could trigger ALUC compatibility review, for which the entity proposing the SOI is responsible for obtaining.

I also know you mentioned that you would not be submitting an official comment letter, however, after speaking with the PBES Director, would it be possible to get an email from, to include in the official record, acknowledging that we met and that your concerns have been addressed/clarified? It would be greatly appreciated.
