## AMENDMENT NO. 3 TO SILVERADO COMMUNITY SERVICES DISTRICT AGREEMENT NO. 230085B (SCSD)

THIS AMENDMENT NO. 3 OF SILVERADO COMMUNITY SERVICES DISTRICT AGREEMENT NO. 230085B (SCSD) is made and entered into as of this 1st day of July 2025, by and between SILVERADO COMMUNITY SERVICES DISTRICT, a special district organized under the laws of the State of California, hereinafter referred to as "DISTRICT," and SANCHEZ BROTHERS LANDSCAPE, INC., a "California S Corporation" whose business address as 1245 Hale Street, Vallejo, California, 94591, hereinafter referred to as "CONTRACTOR."

## RECITALS

**WHEREAS**, on July 1, 2022, DISTRICT and CONTRACTOR entered into an Agreement to provide landscape maintenance services; and

**WHEREAS**, on September 13, 2022, DISTRICT and CONTRACTOR amended the Agreement to increase the periodic and maximum payment amounts allowable under the Agreement (Amendment No. 1); and

**WHEREAS**, on May 23, 2023, DISTRICT and CONTRACTOR amended the Agreement again to increase the periodic and maximum payment amounts allowable under the Agreement (Amendment No. 2); and

**WHEREAS,** DISTRICT and CONTRACTOR now wish to enter into this Amendment No. 3 to amend the Agreement to extend the term to June 30, 2027.

## **TERMS**

**NOW, THEREFORE**, DISTRICT and CONTRACTOR amend Silverado Community Services District Agreement No. 230085B (SCSD) (the "Agreement") as follows:

1. Paragraph 1 of the Agreement is amended in its entirety to read as follows:

Term of the Agreement. The term of this Agreement shall commence on July 1, 2022, and shall expire on June 30, 2027, unless terminated earlier in accordance with Paragraphs 9 (Termination for Cause), 10 (Other Termination) or 23(a) (Covenant of No Undisclosed Conflict); except that the obligations of the parties under Paragraphs 7 (Insurance) and 8 (Hold Harmless/Defense/Indemnification) shall continue in full force and effect after said expiration date or early termination in relation to acts or omissions occurring prior to such dates during the term of the Agreement, and the obligations of CONTRACTOR to DISTRICT shall also continue after said expiration date or early termination in relation to the

obligations prescribed by Paragraphs 15 (Confidentiality), 20 (Taxes) and 21 (Access to Records/Retention). For purposes of this Agreement, "fiscal year" shall mean the period commencing on July 1 and ending on June 30.

2. Except as provided in paragraph 1, above, all other terms and provisions of the Agreement shall remain in full force and effect as originally agreed.
