8. BOARD OF SUPERVISORS REPORTS AND ANNOUNCEMENTS

Supervisor Anne Cottrell reported on attending last week's Rural County Representatives of California (RCRC) meeting where the following was discussed: a presentation on the California State budget - it will be a challenging year ahead, one specific item being the Cal Fire home hardening pilot project went from \$25 million to closer to \$12 to \$13 million; AB 817 related to the Brown Act that will allow more counties to run commission meetings remotely (Napa County supported the bill in concept and will be asked again to support it); AB 491 related to code enforcement that will allow counties to collect more expenses incurred (RCRC is seeking support); AB 702 related to juvenile justice financing that Napa County opposed - the bill was pulled and may be coming back in a different form; and Supervisor Cottrell was appointed to an hoc committee on the Williamson Act which helps agricultural producers preserve farmland and we need to continue to look at how to support that and blend it with the State's conservation goals.

Supervisor Ryan Gregory reported on the following: attending the Napa Chamber of Commerce's annual luncheon last Friday to support local businesses and the new CEO Jeri Hansen; and attending yesterday's Napa County Commission on Aging meeting where Director of Housing & Homeless Services Jennifer Palmer made a presentation on the Bay Area Housing Finance Authority (BAHFA) pilot senior rental assistance program where Napa County received a \$5 million grant.

Supervisor Alfredo Pedroza reported on attending a California State Bay Area Caucus meeting in Sacramento yesterday to discuss a potential regional measure for the 2026 ballot. The focus is on transit users and how to restore transit in a different way and looking at legislation that creates more revenue for transit and also gives the Metropolitan Transportation Commission (MTC) more authority to encourage more collaboration and consolidation work.

Supervisor Belia Ramos reported the following; attending a meeting with Assemblymember Cecilia Aguiar-Curry regarding a legislative fix for the State's vehicle licensing fee shortfall and commended the efforts of Treasurer-Tax Collector Robert Minahen and County Executive Office Legislative and Policy Analyst Andrew Mize - the Governor's proposed budget contains significant revenue shortfalls, including a \$2 million ABAG claw back for regional early action planning; attending an ABAG meeting last Thursday where she was appointed as President of the Executive Board; and being appointed as Treasurer of the California State Association of Counties (CSAC) and attending an Executive Board retreat later this month.
